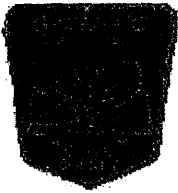
Incident Disposition Comments :

On 03/30/2013 I, Deputy Carney along with Sgt. Kuhn was dispatched to I-94, MM 70.5 on the north side for a dispute. Cal Berger called and reported he and his crew were on scene trying to repair damaged fiber optic lines that had phone lines including 911 non-operative. Cal reported a couple of guys showed up with dogs saying Cal had to leave as it was there property.

Upon arrival I spoke with Cal briefly who told me what dispatch already advised me of. I then spoke with Michael Fanzo who was in a white pickup down the hill on a make shift dirt road running north/south. Michael was saying it was his property which I found out after a few minutes of talking to him he just rented the land from the actual owner. Michael kept saying the crew with Century Link did not have papers showing they had an easement giving them a right to be on the property. After it was explained to Michael by Sgt. Kuhn why Century Link was there he agreed to leave the area and let them do their work without bothering them anymore. I obtained Michael's name, date of birth and address. Michael calmed down a lot after a few minutes and told me he was just upset at first asking me, "Wouldn't you be upset if someone showed up on your land wanting to dig?" Michael told me he completely understood why they were there and that he would leave them alone for the duration of there stay. Michael thanked me and shook my hand and drove away.

I then obtained Cal's information as well and told him if he had any more problems to just call us back again. I cleared the scene shortly after.

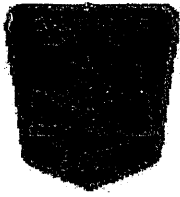

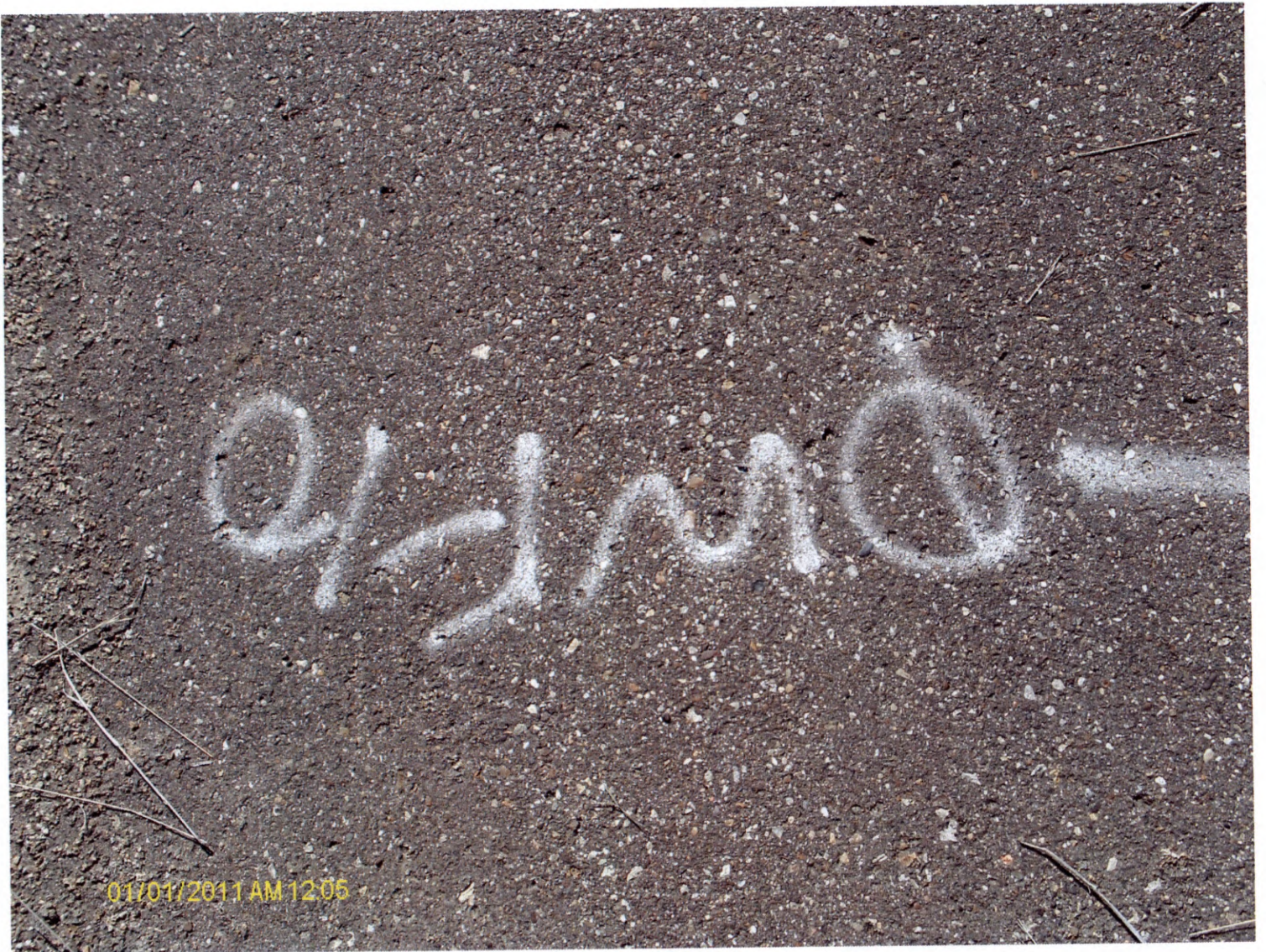
