The undersigned, being duly sworn under oath and of lawful age, declares and states as follows:


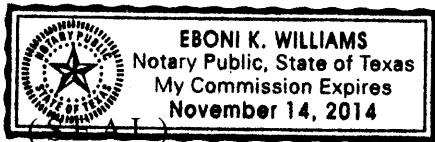
1. That Enbridge Pipelines (Bakken) L.P. is a Delaware limited partnership, registered to do business with the North Dakota Secretary of State.
