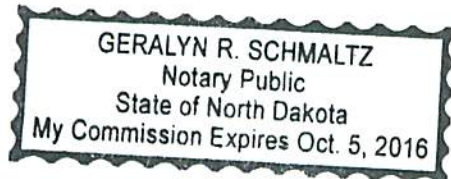



**ORDER REISSUING CERTIFICATE AND PERMIT**

**June 5, 2013**

On May 5, 2011, in Case No. PU-10-612, the Commission issued Certificate of Corridor Compatibility No. 118 and Route Permit No. 128 to Enbridge Pipelines (North Dakota) LLC for the replacement of approximately 11 miles of Enbridge's 12-inch diameter Line 26 pipeline beginning at milepost 29 and ending at milepost 40 located in Burke County, North Dakota.

On September 6, 2011, the Commission approved the amendments from the permitted corridor and pipeline route and issued First Amended Certificate of Corridor Compatibility No.118 and First Amended Route Permit No. 128.

On April 8, 2013, Enbridge Pipelines (North Dakota) LLC and Enbridge Pipelines (Bakken) L.P. (Enbridge Bakken) submitted a joint application for the transfer of Certificate of Corridor Compatibility Number 118 and Route Permit Number 128 to Enbridge Bakken, Case No. PU-13-153.

On April 24, 2013, the Commission issued a Notice of Opportunity for Hearing that provided until May 29, 2013 for receiving written comments or requests for hearing. No comments or requests for hearing were received. The notice stated the issues to be considered are whether Enbridge Bakken agrees and is able to comply with the terms and conditions of Corridor Compatibility Number 118 and Route Permit Number 128 to Enbridge ND, and whether the requested transfer is compatible with the public interest.

The April 19, 2013 affidavit of Chris Kaitson, Vice President and Assistant Secretary of Enbridge Pipelines (Bakken), LLC states that Enbridge Bakken agrees to assume the rights and obligations of Certificate of Corridor Compatibility Number 118 and Route Permit Number 128, including the conditions and limitations set forth in the Commission's Findings of Fact, Conclusions of Law, and Order, dated May 5, 2011, issuing said Certificate and Route Permit, Case No. PU-10-612.

The requested transfer is compatible with the public interest.

**Order**

The Commission Orders:

1. The application for transfer of Certificate of Corridor Compatibility Number 118 and Route Permit Number 128 is granted.
2. First Reissued, First Amended Certificate of Corridor Compatibility Number 118 and First Reissued, First Amended Route Permit Number 128 are issued to Enbridge Pipelines (Bakken) L.P.


