**ORDER REINSTATING WAREHOUSE LICENSE**

**June 4, 2013**

Northwood Bean Co., Inc. operates a licensed public grain warehouse at Northwood, North Dakota, under license number 1136, issued by the Public Service Commission under the provisions of North Dakota Century Code Chapter 60-02.

On February 22, 2013, the Commission was notified that the \$200,000 grain warehouse bond issued to Northwood Bean Co., Inc. would be cancelled effective May 24, 2013. As provided in North Dakota Century Code § 60-02-09.1, the company's warehouse license was suspended effective April 24, 2013, for failing to file proof of new or renewed bond at least thirty days before cancellation of the current bond filing.


Northwood Bean Co., Inc. had until May 23, 2013, to procure and file proof of new or renewed bond or submit a written request for hearing. Northwood Bean Co., Inc. filed a request to decrease the license capacity at Northwood from 383,000 bushels to 97,000 bushels to reflect the deletion of facilities no longer used to store grain including off-site leased storage. The capacity decrease request was approved effective May 20, 2013, decreasing the bond obligation from \$200,000 to \$50,000. On May 21, 2013, the Commission received a replacement bond, in the amount of \$50,000, issued to Northwood Bean Co., Inc.

**Order**

The bond requirements have now been met and the Commission orders that:

1. Warehouse license number 1136 issued to Northwood Bean Co., Inc. is reinstated, effective May 21, 2013, and
2. Northwood Bean Co., Inc. is authorized to operate a 97,000 bushel public grain warehouse at Northwood as governed by North Dakota Century Code Chapter 60-02.
