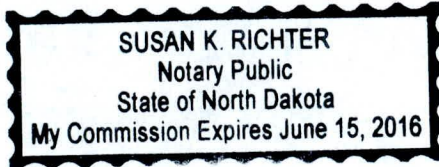

1. The Public Service Commission as Trustee of the Trust Fund provided by North Dakota Century Code section 60-04-03 for the purpose of marshalling all trust assets of Earth Harvest Mills, Inc., an insolvent grain warehouse, seeks an Order Approving the Report and Recommendation of Trustee, Requiring Deposit of Bond Proceeds, Approving Payment, and Discharging Trustee. The Trustee has the authority to bring this Motion and the Court has the power to grant the relief requested under North Dakota Century Code sections 60-04-03 and 60-04-07.
2. North Dakota Century Code section 60-02-09 requires that a bond must be filed with the Public Service Commission before any license can be issued to any public warehouseman in North Dakota. The bond is for the purpose of protecting holders of outstanding receipts and covering the costs incurred by the Trustee in the administration of the licensee's insolvency. The insolvent licensee, Earth Harvest Mills, Inc., had such a bond, issued by Washington International

Insurance Company, 475 North Martingale Road #850, Schaumburg, Illinois as surety.

3. By Motion filed March 7, 2014 and Notice of Motion served March 13 2014, the Trustee requested joinder of the surety, Washington International Insurance Company, as a Respondent. As of the date of the instant Motion which this Brief supports, Washington International insurance Company has not yet been joined as a Respondent in this action.
4. The Trustee has reviewed claims filed against the warehouseman. The Trustee's conclusions and recommendations regarding the validity of each claim are summarized in the Report and Recommendation of Trustee and detailed in Exhibit A, attached to the Report and Recommendation of Trustee.
5. The proceeds from the bond will be needed to redeem outstanding receipts issued by Earth Harvest Mills, Inc. as provided in North Dakota Century Code section 60-04-09. The Court has jurisdiction under North Dakota Century Code section 60-04-03.3 to order the deposit of bond proceeds.
6. The Trust Fund will be made up of bond proceeds only. As noted in the Report and Recommendation of Trustee, there were no grain assets in the warehouse at the time of the insolvency.
7. Under North Dakota Century Code section 60-04-03.1 the "trust fund shall be established for the benefit of noncredit-sale receipt holders of the insolvent warehouseman and to pay the costs incurred by the commission in the administration of this chapter. . . ." The Credit-Sale Contract Indemnity Fund was created for the purpose of providing protection for persons selling grain to a

North Dakota licensed warehouse. North Dakota Century Code section 60-10-02. A person is eligible to receive payment from the Credit-Sale Contract Indemnity Fund if the warehouse licensed under North Dakota law to which the person sold grain becomes insolvent and has not fully compensated the person in accordance with the credit-sale contract. North Dakota Century Code section 60-10-04.

8. Proceeds from the Credit-Sale Contract Indemnity Fund will be needed to meet the licensee's obligations to holders of credit-sale contracts. North Dakota Century Code section 60-10-05 provides:

Upon the insolvency of a licensed warehouse or grain buyer and a declaration that the public service commission serve as the trustee, the public service commission shall make the proceeds of the credit-sale contract indemnity fund available for use in meeting the licensee's obligations with respect to the reimbursement of any person who sold grain to the licensee under a credit-sale contract and who was not fully compensated in accordance with the contract.

9. Under North Dakota Century Code section 60-10-06, the amount payable to any eligible person from the Credit-Sale Contract Indemnity Fund may not exceed the lesser of eighty percent (80%) of the amount owed to that eligible person under that person's unsatisfied credit-sale contracts or two hundred eighty thousand dollars (\$280,000).
10. North Dakota Century Code section 60-10-09 provides that expenses incurred in administering the Credit-Sale Contract Indemnity Fund are reimbursable from the fund. In its Report and Recommendation, the Trustee requests reimbursement for one-half of the expenses of administration of the insolvency from the Credit-Sale Contract Indemnity Fund. The total amount of expenses incurred to date is

\$272.51 and one-half is \$136.26, as identified in Exhibit B, attached to the Report and Recommendation. The final amount to be reimbursed will be determined once the Court approves the Report and Recommendation of Trustee and payments are complete.

11. North Dakota Century Code section 60-04-09 provides in part:

Following hearing, the court shall approve or modify the report and issue an order directing payment of the necessary bond proceeds, distribution of the trust fund, and discharge of the commission from its trust.

12. The Trustee respectfully requests that the Court approve the Report and Recommendation of Trustee, join the surety, Washington International Insurance Company, if not already joined when this matter is heard, require deposit of bond proceeds, authorize distribution of bond proceeds to valid noncredit-sale contract (cash) claimants and authorize Credit-Sale Contract Indemnity Fund payments to valid credit-sale contract claimants and for reimbursement of the expenses of administration, and following payment, discharge the Trustee.

REPORT AND  
RECOMMENDATION  
OF TRUSTEE



1. The Public Service Commission, as Trustee, makes the following Report and Recommendation to the Court:
2. Earth Harvest Mills, Inc. dba Dakota Prairie Organic Flour Company (Earth Harvest Mills), a North Dakota business corporation, operated a grain warehouse at Harvey, North Dakota, licensed under North Dakota Century Code Chapter 60-02. Earth Harvest Mills, Inc. operated under license number 1155.
3. As part of the licensing process, Earth Harvest Mills filed a bond, as required by North Dakota Century Code section 60-02-09, in the amount of \$50,000.00 and identified as number 9145595, with Washington International Insurance Company, 475 North Martingale Road #850, Schaumburg, Illinois as surety.
4. On April 26, 2013, Delbert Cousins, Weirdale, Saskatchewan, Canada, filed with the Public Service Commission, a letter for collection of outstanding funds owed

Mr. Cousins by Earth Harvest Mills for grain delivered. Subsequently, twenty five others filed letters for collection of outstanding funds owed them for grain delivered to Earth Harvest Mills.

5. The week of April 29, 2013 Timothy Erdmann, Public Service Commission Grain Warehouse Inspector, confirmed there was no grain inventory at the Harvey, North Dakota facility.
6. On May 1, 2013, the Public Service Commission filed an Application under North Dakota Century Code Chapter 60-04 for Appointment as Trustee and for Ex Parte Order in District Court, County of Wells, Southeast Judicial District.
7. On May 2, 2013, the District Court issued an Order prohibiting Earth Harvest Mills from selling, transferring, removing, processing, or otherwise compromising potential assets of the Trust Fund until the Court issues its order granting or denying the application for appointment of the Public Service Commission as Trustee of the Trust Fund.
8. On May 10, 2013, a copy of the Notice of Entry of Order with attached copy of the executed Ex Parte Order to Preserve Trusts Assets was served by certified mail on Earth Harvest Mills and also sent by regular mail to the surety and twenty five potential claimants identified from the records of the Public Service Commission and Earth Harvest Mills.
9. On June 14, 2013, the District Court issued an Order appointing the Public Service Commission Trustee of the Trust Fund under North Dakota Century Code Chapter 60-04 for the purpose of marshaling all trust assets of the

insolvent Earth Harvest Mills, Inc. doing business as Dakota Prairie Organic Flour Company and establishing the date of insolvency as April 26, 2013.

10. On June 25, 2013, a copy of the Notice of Order Appointing Trustee with attached copy of the executed Order Appointing Trustee, and a copy of the Notice of Appointment as Trustee and Notice to File Claims, was served on Earth Harvest Mills by certified mail and also sent by regular mail to the surety and twenty-six potential claimants in the insolvency proceeding. The notice required the filing of claims within forty-five days of the second publication of the notice.
11. On June 29, 2013 and July 6, 2013, the Notice of Appointment as Trustee and Notice to File Claims was published as a legal publication in The Herald-Press, Harvey, North Dakota, as required by North Dakota Century Code section 60-04-03.3. The Herald-Press is located in Wells County and is the official county newspaper of the county in which the Harvey warehouse is located.
12. On March 7, 2014, the Trustee filed a Motion to Join Surety asking the Court to order Washington International Insurance Company joined as a Respondent under North Dakota Century Code section 60-04-03.3. The Notice of Motion, Motion and Brief in Support of Motion, under Rule 3.2 of the North Dakota Rules of Court, were served on Earth Harvest Mills and Washington International Insurance Company by certified mail, and on others via the Odyssey Electronic Service and File System and regular mail.
13. Twenty-six claims totaling \$4,351,571.30 were filed, and are identified below. Additional detail on each claim is provided in Exhibit A, attached to this report.

14. At the time of insolvency, there were no grain assets in the warehouse at Harvey, North Dakota.
15. The \$50,000 bond proceeds are needed to redeem outstanding claims for grain purchased by means other than by credit-sale contract by Earth Harvest Mills through its Harvey, North Dakota facility.
16. When the bond proceeds are paid over to the Trustee, there will be funds available from the Trust Fund to pay each valid noncredit-sale contract (cash) claimant approximately 62% of the respective valid claim.
17. The Trustee recommends that each noncredit-sale contract (cash) claimant be paid approximately 62% of the respective valid claim. The Trustee recommends that payment for each noncredit-sale contract (cash) claim be made jointly payable to the claimant and relevant valid lien holders at the time checks are issued. The final amounts to be paid will be determined once Court approval is received.
18. The Trustee recommends finding seven noncredit-sale contract (cash) claims valid totaling \$80,973.26. Valid noncredit-sale contract claims are identified below and with additional detail in Exhibit A, attached.

19. The Trustee recommends that one noncredit-sale contract (cash) claim in the amount of \$54,041.53 be determined invalid because the claim is not for grain delivered to Earth Harvest Mills and is therefore nonjurisdictional, as shown with detail in Exhibit A, attached.
20. Proceeds from the Credit-Sale Contract Indemnity Fund will be needed to meet the insolvent licensee's obligations to valid credit-sale contract claimants.
21. The Trustee recommends that payments to each valid credit-sale contract claimant be made as specified in North Dakota Century Code section 60-10-06 in the amount of 80% of the claimant's valid credit-sale contract claim, up to a maximum of \$280,000. The Trustee recommends that payment for each credit-sale contract claim be made jointly payable to the claimant and relevant valid lien holders at the time checks are issued.
22. The Trustee recommends payments on valid credit-sale contract claims totaling \$2,402,901.24. Valid credit-sale contract claims and amounts payable are identified below and with additional detail in Exhibit A, attached:

23. North Dakota Century Code section 60-10-09 provides that expenses incurred in administering the Credit-Sale Contract Indemnity Fund are reimbursable from the fund. The Trustee requests reimbursement for one-half of the expenses of administration of the insolvency from the Credit-Sale Contract Indemnity Fund. The total amount of expenses incurred to date is \$272.51 and one-half is \$136.26, as identified in Exhibit B, attached. The final amount to be reimbursed will be determined once the Court approves the Report and Recommendation of Trustee and payments are complete.
24. Contemporaneously with the filing of this Report and Recommendation a motion to approve the Report and Recommendation of Trustee, require deposit of bond proceeds, approve payments, and discharge Trustee is being filed with the North Dakota District Court located in Wells County North Dakota. The Court has

scheduled a hearing on this matter for May 14, 2014 at 3:30 p.m. CDT. Any interested party may appear at the hearing to show cause why the Report and Recommendation should not be approved.

**WHEREFORE the Trustee asks the Court to:**

25. Approve the Report and Recommendation of Trustee.
26. Join the surety, Washington International Insurance Company, 475 North Martingale Road #850, Schaumburg, Illinois, as a Respondent, if not already joined when this matter is heard.
27. Order the surety, Washington International Insurance Company, 475 North Martingale Road #850, Schaumburg, Illinois, to deposit with the Trustee \$50,000, the total amount of the bond proceeds, within 10 days after service of Notice of Entry of Judgment.
28. Authorize the Public Service Commission, as Trustee, to make payments of Trust Fund proceeds consistent with this Report and Recommendation to persons with valid noncredit-sale contract (cash) claims for grain purchased for cash by Earth Harvest Mills, Inc., dba Dakota Prairie Organic Flour Company at Harvey, North Dakota.
29. Authorize the Public Service Commission, as Trustee, to make payments from the Credit-Sale Contract Indemnity Fund consistent with this Report and Recommendation to persons with valid credit-sale contract claims for grain purchased via credit-sale contract by Earth Harvest Mills, Inc., dba Dakota Prairie Organic Flour Company at Harvey, North Dakota.

30. Authorize the Public Service Commission, as Trustee, to make payments from the Credit-Sale Contract Indemnity Fund consistent with this Report and Recommendation to reimburse the Public Service Commission for one-half the expenses of administration of the insolvency.
31. Discharge the Public Service Commission, as Trustee, once all Trust Fund assets have been distributed and all Credit-Sale Contract Indemnity Fund payments have been made.

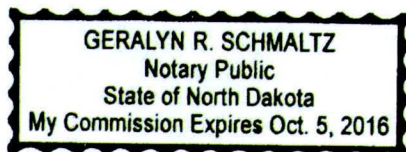


