The accompanying tariff, North Dakota P.S.C. No. 89, issued by Tesoro High Plains Pipeline Company, LLC (THPP), is submitted to you for filing to become effective on July 1, 2013.

North Dakota P.S.C. No. 89 cancels North Dakota P.S.C. No. 88. All rates in North Dakota P.S.C. No. 89 have been increased. In addition, Rangeland Energy LLC has been struck from the origin at Dry Fork Station, Williams County because it is no longer an operator at that facility.

Pursuant to Section 49-05-05 of the North Dakota Century Code, THPP hereby requests that the Commission permit the changes indicated in this tariff to become effective on less than 30 days' notice.
