**ACCEPTANCE OF PROVISIONS OF  
NORTH DAKOTA CENTURY CODE §49-19-12**

Enbridge Pipelines (North Dakota) LLC (“Enbridge”) owns and operates interstate pipelines located within the State of North Dakota and is engaged in the business of transporting crude petroleum for others by such pipelines.

North Dakota Century Code §49-19-12 provides in part that “every common pipeline carrier which shall have filed with the Commission its acceptance of the provisions of this chapter has, subject to Chapter 32-15, the right and power of eminent domain in the exercise of which it may enter upon and condemn the land, right of way, easements, property of any person necessary for the construction, maintenance, or authorization of its pipeline.”

Enbridge, pursuant to North Dakota Century Code §49-19-12, as a common carrier, accepts the provisions of Chapter 49-19 of the North Dakota Century Code. This acceptance by Enbridge is hereby filed with the North Dakota Public Service Commission.
