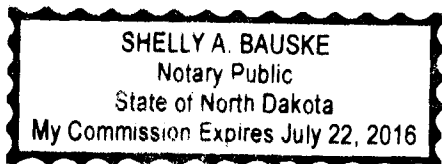

**ORDER GRANTING REQUEST  
TO DISCONTINUE BUSINESS**

**July 30, 2013**

Engstrom Bean and Seed, Inc. of Leeds, North Dakota operates licensed public grain warehouses at Cando and Petersburg, North Dakota, under license numbers 1106 and 1163 respectively issued by the Public Service Commission under the provisions of North Dakota Century Code Chapter 60-02. The Commission received a request to discontinue business for these facilities.

**Order**

The Commission orders:

1. Warehouse license numbers 1106 and 1163 issued to Engstrom Bean and Seed, Inc. are cancelled effective immediately and Engstrom Bean and Seed, Inc. shall remit license numbers 1106 and 1163 to the Commission; and
2. Business at Cando and Petersburg, North Dakota, are discontinued effective immediately and Engstrom Bean and Seed, Inc. shall not conduct any further business under license numbers 1106 and 1163.
