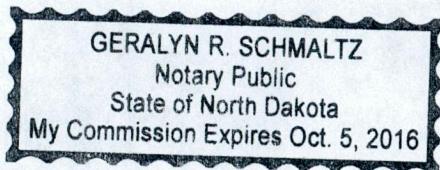

ORDER REISSUING CERTIFICATE AND PERMIT

November 13, 2013

On April 11, 2012, in Case No. PU-11-683, the Commission issued Certificate of Corridor Compatibility No. 131 and Route Permit No. 140 to ONEOK Rockies Midstream, LLC for the construction of approximately 13 miles of 10.75-inch diameter pipeline in Williams County, North Dakota to transport natural gas from the tailgate of the Stateline 1 and 2 Gas Processing Plants near Williston, North Dakota to a point on the North Dakota and Montana border and then to the Riverview Rail Terminal in Richland County, Montana.

On August 12, 2013, ONEOK Rockies Midstream, LLC (ORM) and ONEOK Bakken Pipeline, LLC (OBP) submitted a joint application for the transfer of Certificate of Corridor Compatibility Number 131 and Route Permit Number 140 to OBP, Case No. PU-13-737.

On September 11, 2013, the Commission issued a Notice of Opportunity for Hearing that provided until October 15, 2013 for receiving written comments or requests for hearing. No comments or requests for hearing were received. The notice stated the issues to be considered are whether OBP agrees and is able to comply with the terms and conditions of Corridor Compatibility Number 131 and Route Permit Number 140 issued to ORM, and whether the requested transfer is compatible with the public interest.

The October 28, 2013 affidavit of Roger Thorpe, Vice President – NGL Operations, ONEOK Bakken Pipeline, L.L.C. states that OBP agrees to assume the rights and obligations of Certificate of Corridor Compatibility Number 131 and Route Permit Number 140, including the conditions and limitations set forth in the Commission's Findings of Fact, Conclusions of Law, and Order, dated April 11, 2012, issuing said Certificate and Route Permit, Case No. PU-11-683.

The requested transfer is compatible with the public interest.

Order

The Commission Orders:

1. The application for transfer of Certificate of Corridor Compatibility Number 131 and Route Permit Number 140 is granted.

2. First Reissued Certificate of Corridor Compatibility Number 131 and First Reissued Route Permit Number 140 are issued to ONEOK Bakken Pipeline, L.L.C.
