On October 4, 2013, Zeviel Simpser (North Dakota Bar # 06794), of the firm of Briggs and Morgan, P.A., 2200 IDS Center, 80 South 8th Street, Minneapolis, Minnesota, filed a Motion for Admission Pro Hac Vice with the North Dakota Public Service Commission. The motion seeks Admission Pro Hac Vice of Kari L. Valley, Assistant General Counsel for Xcel Energy Services Inc., 414 Nicollet Mall, Minneapolis, Minnesota. Ms. Valley seeks admission to practice pro hac vice in North Dakota, representing Northern States Power Company before the Public Service Commission in several cases, namely, Northern States Power Company PU-13-706, PU-13-707, PU-13-708, PU-13-742 and PU-13-743.
