The Company has entered into contracts with Geronimo Energy to purchase electric energy from the *Courtenay* Wind Farm to be located northeast of Jamestown, North Dakota and the *Odell* Wind Farm to be located near Mountain Lake, Minnesota. We have also entered into a contract with RES Americas to develop the *Pleasant Valley* Wind Farm near our Grand Meadow Wind Farm in southeastern Minnesota and, once complete, transfer ownership of the plant to us. Xcel Energy will then own and operate the facility.

The wind generation market has presented us with a unique opportunity to add significant generation that will keep energy prices lower for our customers than otherwise would be the case and at the same time improve the environmental performance of our system. To capture the benefits of the Production Tax Credit, the projects must be substantially started by the end of 2013.

Accordingly, we respectfully request that the Commission determine, by November 1, 2013, that our proposal to enter into these wind projects is cost-effective and prudent. The Company's Application and supporting testimony contains trade secret information. In accordance with Section 69-02-09-02 of the North Dakota Administrative Code, an Application for Trade Secret Protection is being provided along with a single copy of the trade secret version of the Application and testimony in a sealed envelope marked **TRADE SECRET-PRIVATE**.

An original and seven copies of the public version of our Application are also being provided, along with the following:

- Direct testimonies of Company Witnesses Laura McCarten and Steven Wishart (public version), supporting the Company's Application;
- Verifications for the testimonies of Ms. McCarten and Mr. Wishart;
- CD containing the public version of the Application, testimonies and verifications, and Application for Trade Secret Protection; and
- Filing fee of \$250,000, an initial amount agreed to through discussions with Commission Staff. It is understood that the Company will submit additional fees - up to the maximum \$525,000 for all three dockets - if it is later deemed necessary by staff to cover the costs to review these projects.
