

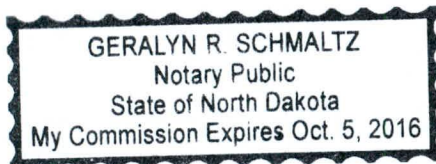

Complaint

The North Dakota Public Service Commission Advocacy Staff (Staff), for its complaint against Selland Construction Inc., alleges and shows the following:

I

Selland Construction Inc. (Selland) is a registered North Dakota foreign business corporation with offices located at 5805 Sherman Lane, Williston, ND 58801.

II

Montana-Dakota Utilities Co (MDU) is a North Dakota corporation with offices located at 400 N 4th St, Bismarck, ND 58501-4022.

III

N.D.C.C. § 49-23-05(5) provides:

To avoid damage to and minimize interference with underground facilities in and near the construction area, an excavator shall conduct the excavation in a careful and prudent manner.

IV

N.D.C.C. § 49-23-06(1)(a) provides:

If any damage occurs to an underground facility or its protective covering, the excavator shall notify the operator as soon as reasonably possible.

V

N.D.C.C. § 49-23-06(1)(c) provides:

An excavator who knowingly damages an underground facility and who does not notify the operator as soon as reasonably possible or who backfills in violation of subdivision b is guilty of a class A misdemeanor.

VI

On September 17, 2013, the Commission received a Third Party Damage Complaint from Paul Reily, District Gas Superintendent for MDU, attached as Exhibit 1, alleging a violation by Selland of N.D.C.C. ch. 49-23, the One-Call Excavation Notice System.

VII

By its October 10, 2013 letter, Staff informed Selland of MDU's complaint filing, and asked for a response by November 1, 2013. Selland's October 21, 2013 response asserted that the gas line damaged was not an active line and thus the severity should be looked at in a different context than that of an active line.

VIII

As alleged by MDU's complaint, on July 19, 2013, Selland began an excavation as defined in N.D.C.C. § 49-23-01(7) while installing the natural gas distribution system and other utilities at Meadows Subdivision, corner of 70th Street East and University

Avenue North, Williston, North Dakota. As a result of Selland excavating a common trench for these utility installations, damage was caused on July 19, 2013, to three gas service lines, a 2-inch gas main, and a 4-inch gas main, all owned and operated by MDU. MDU alleges that the cost to repair its facilities was approximately \$3266.86.

IX

Based on its investigation, Staff determined that on July 12, 2013, Selland personnel provided an excavation notice to the North Dakota One Call (NDOC) Notification Center with work to begin on July 16, 2013 at 70th St E and 2nd Ave W in Williston, ND. The NDOC Notification Center assigned locate ticket number 13099771 to the excavation notice. The underground facilities were located and marked as accurately as possible, and the facility marks were visible in the area of excavation. On July 19, 2013, Selland personnel began an excavation of a common trench for installation of the natural gas distribution system and other utilities. As a result of this excavation, damage was caused by mechanized equipment to MDU facilities. MDU was not notified of the damage until July 24, 2013. No customers were affected. Selland reimbursed MDU for the damages.

X

Selland violated N.D.C.C. § 49-23-05(5) by failing to conduct the excavation in a careful and prudent manner.

XI

Selland violated N.D.C.C. § 49-23-06(1)(a) by failing to notify the operator as soon as reasonably possible of damage caused to an underground facility.

XII

North Dakota Century Code § 49-07-01.1 provides:

Any person who violates any statute, commission order, or commission rule which applies to matters within the authority of the commission under chapters 8-08, 8-09, 8-10, 24-09, 32-25, and 51-05.1, titles 60 and 64, and title 49 except for chapter 49-22, shall, in addition to any other penalty provided, be subject to a civil penalty of not to exceed five thousand dollars. The civil penalty may be compromised by the commission. The amount of the penalty when finally determined or agreed upon in compromise, if not paid, may be recovered in a civil action in the courts of this state.

XIII

The North Dakota Public Service Commission Damage Prevention Plan provides:

D PROPOSED CIVIL PENALTIES:

1. The following criteria must be used by Commission staff to determine if a civil penalty should be proposed when filing a formal complaint:
 - a. The nature, circumstances and severity of the complaint;
 - b. The degree of suspected fault on the part of the respondent;
 - c. The respondent's history of prior violations or complaints;
 - d. The respondent's ability to pay;
 - e. Any good faith effort by the respondent in attempting to achieve compliance; and
 - f. The effect the penalty may have on the respondent's ability to continue in business.

XIV


The Respondent must serve an answer to this complaint upon the Complainant and the Commission within twenty days after service of the complaint, or the Commission may deem the complaint to be admitted. Answers must be served in the manner allowed for service under the North Dakota Rules of Civil Procedure.

Prayer for Relief

Based on the foregoing, Staff seeks the following relief:

1. That the Commission find Selland Construction Inc. in violation of N.D.C.C. ch.49-23 for failing to comply with the One Call requirements enumerated in N.D.C.C. § 49-23-05, and impose a penalty in the amount of \$1,000.00.
2. In addition, that the Commission find Selland Construction Inc. in violation of N.D.C.C. ch.49-23 for failing to comply with the One Call requirements enumerated in N.D.C.C. § 49-23-06(1)(a), and impose a penalty in the amount of \$1,000.00.
3. Such other relief that the Commission finds just and proper.

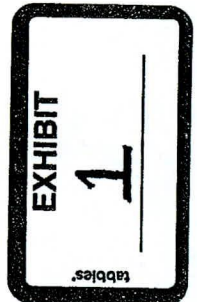

<p>Description of Event</p> <p>While installing the natural gas distribution system in the Meadows Subdivision in the City of Williston, state of North Dakota the contractor made contact with our facilities three separate times.</p> <p>The first time a natural gas service line was struck, and repaired on location at the time of contact.</p> <p>On July 19, 2013 while installing other utilities, the contractor made contact with a four inch main at the point where it tied in with a two inch main branch line, they also made contact with a service line. Montana-Dakota Utilities (MDU) were not made aware of this contact until 24 July, 2013. During this six day time frame Williston, ND received rainfall causing the natural gas main to become contaminated with dirt and water. This caused MDU to excavate and replace over thirty feet of four and two inch gas main line as well as repairing a damaged service line. When the system was tested, the third contact damage to a service line was found which took extensive investigation to find and repair.</p>
