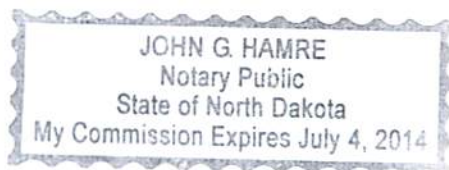



Submitted with the application was a statement by Scott Heley that the customer desires electric service to be provided by the applicant. Service is to be provided at a point located in:


**The SE ¼ of NE ¼ of Section 17, Twp. 131N, R 50W, Richland
