

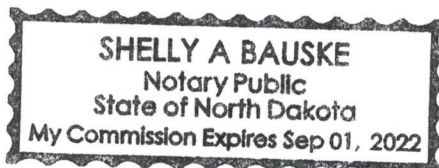

SUPPLEMENTAL ORDER

November 29, 2017

On July 10, 2014, the Commission issued Corridor Certificate No. 154 and Route Permit No. 166 to Montana-Dakota Utilities Co., a Division of MDU Resources Group, Inc. and Otter Tail Power Company (Applicants) authorizing approximately 11 miles of 345 kV electric transmission line and associated facilities from a new Ellendale 345 kV substation to the South Dakota Border in Dickey County. This is the North Dakota portion of an Ellendale to Big Stone project.

On December 16, 2015, the Commission issued First Amended Certificate of Corridor Compatibility No. 154 and First Amended Route Permit No. 166 to Applicants authorizing minor corridor and route modifications in sections 9 & 10 of Ellendale Township T129N, R63W and in Section 32 of Van Meter Township T129N, R62W.

On June 6, 2017 and September 6, 2017, Applicants filed consolidated applications for second amended corridor certificate and route permit, requesting minor corridor and route modifications from transmission line structures 29 to 32 in section 20 of Van Meter Township.

On October 4, 2017, the Commission found the consolidated amendment applications complete and issued a Notice of Filing and Notice of Opportunity for Hearing, which provided until November 10, 2017 for receiving written comments and hearing requests. No hearing requests were received. The notice identified the following issues to be considered in this matter:

1. Will the location, construction, and operation of the proposed facilities produce minimal adverse effects on the environment and upon the welfare of the citizens of North Dakota?
2. Are the proposed facilities compatible with the environmental preservation and the efficient use of resources?
3. Will the proposed facility locations minimize adverse human and environmental impact while ensuring continuing system reliability and integrity and ensuring that energy needs are met and fulfilled in an orderly and timely fashion?

On October 30, 2017, the North Dakota Department of Health comments stating that it believes environmental impacts from the proposed construction will be minor and can be controlled by proper construction methods.

On November 8, 2017, the North Dakota State Water Commission filed comments that initial review indicates the project does not require permits relative to the National Flood Insurance Program or a conditional or temporary permit for water appropriation.

Applicants report that proximity to an existing 115 kV transmission line poses safety hazards during construction, resulting in a need for corridor and route modifications necessary to shift structure #30 about 150 feet west and Structure #31 approximately 80 feet

to the southwest. No new landowners are involved and the landowner whose land the shifts occur on has given approval. No exclusion or avoidance areas have been identified within the proposed corridor and route modifications.

The location, construction, and operation of the proposed facilities will produce minimal adverse effects on the environment and upon the welfare of the citizens of North Dakota.

The proposed facilities are compatible with the environmental preservation and the efficient use of resources.





