## **EXECUTIVE SUMMARY**

Carlson McCain, Inc. (“McCain”), on behalf of Merjent, Inc. (“Merjent”) and Enbridge, conducted wetland and waterbody surveys in North Dakota during the 2013 growing season. Wetland and waterbody surveys were completed for 11,483.34 acres of the total 13,822.1 acre environmental survey corridor (83 percent). The remaining areas were not surveyed due to access restrictions or corridor modifications. Surveys will be conducted in the remaining areas during the 2014 growing season.

Wetland and waterbody surveys were conducted in accordance with U.S. Army Corps of Engineers (“USACE”) technical guidance. Specific objectives of the wetland and waterbody surveys were to:

- 1) Delineate wetland boundaries;
- 2) Categorize wetland community types of each wetland;
- 3) Locate and characterize waterbodies.

The 2013 wetland and waterbody surveys resulted in the identification of 1,312 wetlands and 117 waterbody features. Wetlands were primarily comprised of palustrine emergent, palustrine scrub-shrub, and palustrine forested vegetative communities. Waterbodies were comprised of Riverine Lower Perennial Unconsolidated Bottom, Riverine Intermittent Streambed, Riverine Ephemeral, Riverine Lower Perennial Unconsolidated Shore, and Riverine Upper Perennial Unconsolidated Bottom.

## **1.0 INTRODUCTION**

Carlson McCain, Inc. (“McCain”), on behalf of Merjent, Inc. (“Merjent”) and Enbridge, conducted wetland and waterbody surveys in North Dakota during the 2013 growing season. Wetland and waterbody surveys were completed for 11,483.34 acres of the total 13,822.1 acre environmental survey corridor (83 percent). The remaining areas were not surveyed due to access restrictions or corridor modifications. Surveys will be conducted in the remaining areas during the 2014 growing season.

### **1.1 PURPOSE OF SURVEYS**

McCain, on behalf of Merjent and Enbridge, conducted wetland and waterbody surveys in North Dakota during the 2013 growing season. Wetland and waterbody surveys were conducted in accordance with U.S. Army Corps of Engineers (“USACE”) technical guidance. The objectives of the wetland and waterbody surveys were to:

- 1) Delineate wetland boundaries;
- 2) Categorize wetland community types of each wetland; and
- 3) Locate and characterize waterbodies.

The environmental survey corridor in North Dakota extends from Enbridge’s Beaver Lodge Station south of Tioga, North Dakota to the North Dakota-Minnesota border, and crosses the following counties: Grand Forks, McHenry, Mountrail, Nelson, Pierce, Ramsey, Towner, Ward, and Williams (Figure 1.1-0). The environmental survey corridor covers approximately 299.27 miles and has an average width of 300 feet.

### **1.2 AGENCY CORRESPONDENCE**

Enbridge, Merjent, and Minnesota Natural Resources, Inc. (“MNR”) met with Barbara Walther of USACE St. Paul District on April 10, 2013 to discuss planned survey protocols. Survey protocols were discussed and concurred with by USACE representatives. Refer to Appendix A for a copy of the correspondence with USACE.

## **2.0 METHODS**

### **2.1 WETLANDS**

Wetland surveys were based on the criteria and methods outlined in the *Corps of Engineers Wetlands Delineation Manual*, Technical Report Y-87-1 (1987), subsequent guidance documents (USACE, 1991, 1992), and applicable Regional Supplements to the *Corps of Engineers Wetland Delineation Manual*.



McCain completed a desktop evaluation of available resources to prepare for the survey effort, which included U.S. Geological Survey topographic maps, Natural Resources Conservation Service (“NRCS”) soil survey data, U.S. Fish and Wildlife Service National Wetland Inventory (“NWI”) data, and aerial photographs. These data were compiled on the same map base to approximate baseline field conditions; Appendix B presents a Map Index of the environmental survey corridor and Appendix C presents detailed maps showing soil and water environmental features.

Onsite wetland delineations were conducted using the three criteria technical approach (i.e., vegetation, soil, and hydrology) as described in the Wetland Field Survey Protocol (see Appendix D), and as defined in the USACE 1987 Manual and the applicable Regional Supplement. According to procedures described in the 1987 Manual and applicable Regional Supplement, areas that under normal circumstances reflect a predominance of hydrophytic vegetation, hydric soils, and wetland hydrology (e.g., inundated or saturated soils) are considered wetlands. Wetland sample points and boundaries were field located and recorded using GPS technology. Collected field data was then reviewed, geospatially corrected, and consolidated for use in corridor evaluation and impact analyses.

## **2.2 WATERBODIES**

Waterbody features were identified, classified, and documented according to the methodology outlined in the Waterbody Field Survey Protocol provided in Appendix D. Waterbodies were field located and delineated using GPS technology. Physical characteristics of each waterbody were field documented, such as top of bank width, ordinary high water mark (“OHWM”) width, top of bank depth, OHWM depth, substrate type, estimated water velocity, approach slope, and water-course type. OHWMs, if present, were identified as defined by USACE Regulatory Guidance Letter (RGL) 05-05.

## **3.0 RESULTS**

### **3.1 SURVEY COMPLETION**

The environmental survey corridor is located within Grand Forks, McHenry, Mountrail, Nelson, Pierce, Ramsey, Towner, Ward, and Williams counties. Wetland and waterbody surveys were completed for 11,483.34 acres of the total 13,822.1 acre environmental survey corridor (83 percent). The remaining areas were not surveyed due to access restrictions or corridor modifications. Surveys will continue in the remaining areas during the 2014 growing season.

### **3.2 WETLAND AND WATERBODY SUMMARY**

2013 wetland and waterbody field surveys identified 1,312 wetlands and 117 waterbodies, illustrated by Cowardin classification in the figures provided in Appendix E and listed in tabular format in Appendix F. Table 3.0-1 identifies the wetland and waterbody Cowardin classes documented in the environmental survey corridor. Soil type, hydrology, vegetative composition, and the Cowardin class of each sampled wetland were documented on the USACE wetland delineation forms provided in Appendix G. Wetland classes observed to be present in the environmental survey corridor include: Palustrine Emergent (“PEM”), Palustrine Scrub-Shrub (“PSS”), Palustrine Forested (“PFO”), and Palustrine Unconsolidated Bottom (“PUB”). Waterbody classes present in the environmental survey corridor include: Riverine Lower Perennial Unconsolidated Bottom (“R2UB”), Riverine Intermittent Streambed (“R4SB”), Riverine

Ephemeral (“R6”), Riverine Lower Perennial Unconsolidated Shore (“R2US”), and Riverine Upper Perennial Unconsolidated Bottom (“R3UB”). Wetland acreage within the environmental survey corridor totaled 1592 acres with Cowardin class acreage identified as follows: 1581 acres of PEM, 2.84 acres of PSS, and 1.1 acres of PFO. Professional judgment was used to identify ditches, which are features that appeared to be mechanically channelized and lacked an OHWM. Appendix F describes the Cowardin class, flow rate, bank height and width, OHWM height and width, substrate, dominate riparian vegetation, waterbody name, and agency designation (if applicable) of each waterbody identified within the environmental survey corridor. Photographs were taken at each sampled wetland and waterbody site to record the general conditions at the time of the field survey, and are presented in Appendix H.
