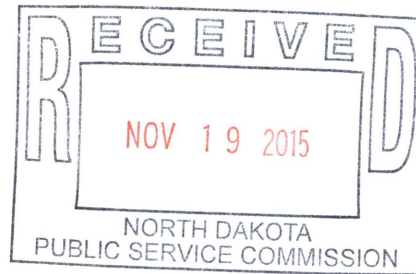

On November 10, 2015, North Dakota Pipeline Company LLC ("NDPL") filed a Route and Corridor Adjustment Request ("Adjustment Request") with the North Dakota Public Service Commission in the above-referenced matter. In the Adjustment Request, NDPL stated that its proposed Nelson County route adjustment is located within 500 feet of an occupied residence, and NDPL would file a copy of a written waiver signed by the landowner upon receipt.

Dear Lawrence E. Bazal:

In association with the Sandpiper Pipeline Project, North Dakota Pipeline Company LLC ("NDPL") is proposing to install a pipeline (hereinafter referred to as the "Facilities") within five hundred (500) feet of an inhabited residence located on your property, described below:

**The Northeast Quarter (NE1/4) of Section Twelve (12), Township One Hundred Fifty-two (152) North, Range Sixty (60) West of the Fifth Principal Meridian, Nelson County, North Dakota.**

(the "Property").


Under North Dakota law (North Dakota Century Code § 49-22-05.1 and North Dakota Administrative Code § 69-06-08-02(2)), the area within five hundred (500) feet of an inhabited residence is an "avoidance area" that shall not be considered by the North Dakota Public Service Commission in the routing of a pipeline unless there is no reasonable alternative or the landowner grants a written waiver of the avoidance area requirement.

By signing this letter where indicated below, you, as owner of the inhabited residence on the Property, acknowledge that you do not object to the placement, or the future operation and maintenance, of the Facilities within five hundred (500) feet of said inhabited residence.




