**STIPULATION FOR  
EXTENSION OF TIME**

**WHEREAS:**

1. The attorney for the appellee, Public Service Commission, contacted the Appellant and the other Appellee to respectfully request an additional extension of time for filing the appellees' briefs, currently due 11 September 2015, due to a demanding workload and limited staff resources. The attorney for the Appellee, Coyote Creek Mining Company, expressed similar concerns and also requested additional time to file.
2. The attorneys in this matter acknowledge the continued demanding schedules of all parties and specifically the current workload in the Public Service Commission.
3. The parties have discussed the matter and all agree to extend the deadline for the filing of the Appellees' briefs to on or before September 30, 2015.
4. This Stipulation may be signed in counterparts, each of which is incorporated into the final document.

5. The undersigned represent and warrant each has the authority to bind the party designated under each person's signature. This Stipulation sets forth all of the terms of the agreement reached between the parties with respect to the subject matter of this Stipulation and supersedes any and all prior negotiations and understandings.
6. Signatures to the Stipulation may be provided by facsimile or other electronic means and will be as binding on the party so providing them as an original signature.
7. This Stipulation is effective as of the date executed by the final party and will remain in effect unless a subsequent stipulation is executed by all the parties hereto or by court order after notice and opportunity to be heard has been given to all parties. No party will be deemed to have waived any rights under this Stipulation absent a written statement of waiver signed by the party alleged to have waived any rights
8. This Stipulation will be construed and interpreted under the laws of the State of North Dakota.


