

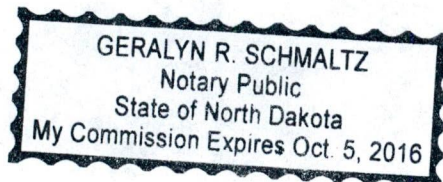

On November 6, 2014, the Public Service Commission found the Complaints state *prima facie* cases and moved the Complaints be served on the Respondent, Northern Excavating Co., Inc.

On December 17, 2014, the Commission issued a Notice of Hearing, consolidating cases GS-13-884, GS-13-885, and GS-14-230 for hearing under North Dakota Administrative Code section 69-02-04-04, and scheduled the hearing for February 3, 2015 at 3:00 p.m.

On February 3, 2015, with the consent of the parties, the Administrative Law Judge continued the hearing on the captioned three cases.





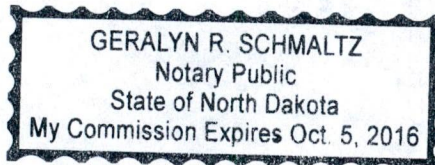
