Enclosed for filing with the North Dakota Public Service Commission (NDPSC) are seven copies of the following tariff issued by North Dakota Pipeline Company LLC (North Dakota Pipeline):

- NDPSC Tariff No. 4, canceling NDPSC Tariff No. 3

This tariff bears an issuance date of December 24, 2013 and an effective date of February 1, 2014.

### **Explanation of Tariff Filing**

NDPSC Tariff No. 4 establishes an initial gathering service and charge at Alexander (McKenzie County), North Dakota (see Table 7). The \$0.1046/bbl interconnection rate resulted from a request for a pipeline interconnection with USG Wheatland Pipeline, LLC to facilitate receipts into the North Dakota Pipeline at Alexander (McKenzie County), North Dakota. Only shippers utilizing this service will be subject to the applicable charge.

Pursuant to 18 CFR 342.2(b), attached to this filing is the affidavit of Feisal Gazie attesting that this rate has been agreed to by at least one non-affiliated shipper who intends to use the service in question.

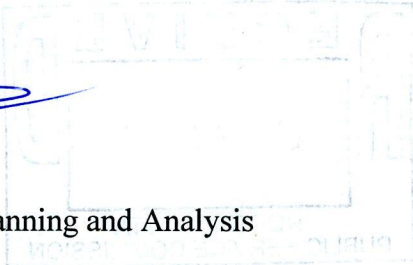

