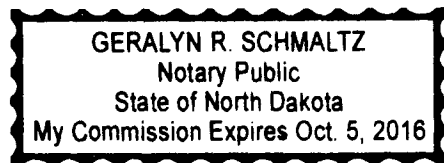


Submitted with the application was a statement by Oasis Petroleum that the customer desires electric service to be provided by the applicant. Service is to be provided at a point located in:


**SW ¼ of the SE ¼ of Section 18, Twp. 156N, R 92W, Mountrail
