**NOTICE OF HEARING**

**April 23, 2014**

On February 27, 2014 Montana-Dakota Utilities Co. (MDU) filed for approval to implement a generation resource cost recovery rider tariff under North Dakota Century Code section 49-05-05. MDU proposes to recover costs associated with its new 88 MW simple cycle combustion turbine generator known as Heskett III located at Mandan, North Dakota. If the rider is approved, the proposed initial increase in customer rates would be:

Res & Small General	Rates 10, 13, 20 & 25	.035 cents/kwh
Large General	Rates 30, 31, 32, 38, 40 & 48	.029 cents/kwh
Lighting	Rates 41 & 52	.020 cents/kwh

A **Public Hearing** on this matter is scheduled to begin on **May 28, 2014**, at **1:00 p.m. central time** in the Commission Hearing Room, 12<sup>th</sup> floor, State Capitol, 600 E Boulevard Ave, Bismarck, ND 58505. The issues to be considered are whether the proposed generation resource cost recovery rider and proposed initial rate increases should be approved.
