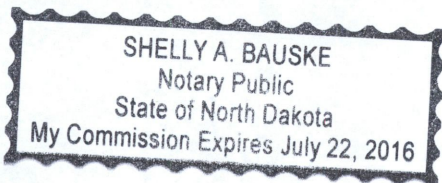

NOTICE OF HEARING

June 22, 2016

On April 14, 2014 Montana-Dakota Utilities Co. (Montana-Dakota) filed a Third Party Damage Complaint alleging a violation of North Dakota Century Code Chapter 49-23 by Plote Construction ND, LLC (Plote).

On April 29, 2014 Public Service Commission Staff mailed a letter to Plote enclosing a copy of the North Dakota One Call Complaint and asking for a response to the Complaint.

On February 3, 2016, Public Service Commission Advocacy Staff filed a formal complaint (Complaint) alleging a violation of the North Dakota One-Call law, North Dakota Century Code Chapter 49-23.

On February 24, 2016 the Public Service Commission found the Complaint states a prima facie case and directed that the Complaint be served on the Respondent, Plote Construction, ND, LLC.

On March 14, 2016 the Complaint was served on the Respondent, Plote Construction, ND, LLC.

On March 21, 2016 Plote filed an Answer to the Complaint.


A public hearing on this matter will be held on **December 1 at 8:30 am CST** in the Commission Hearing Room, State Capitol, 12th Floor, Bismarck, North Dakota 58505. The issues to be considered are:

1. Whether Plote Construction ND, LLC violated North Dakota Century Code Chapter 49-23.
2. If a violation is found, whether the Commission should impose a civil penalty and if so, in what amount.
