OTTER TAIL POWER COMPANY HAS A 41.6 KV TRANSMISSION LINE DIRECTLY ADJACENT TO BARNICK'S FARM SITE. AGREEMENT REACHED WITH JAY JACOBSON, DAKOTA VALLEY ELECTRIC COOPERATIVE GENERAL MANAGER, FOR OTTER TAIL POWER COMPANY TO SERVE 3-PHASE TO THE BIN SITE.
