Dear Mr. Hall:

Enclosed is a copy of a Third Party Damage Complaint against EVERETT HALL, (HALL), received by the North Dakota Public Service Commission (Commission) on May 23, 2014, from CENEX PIPELINE, LLC (CENEX). The location of the ND ONE-CALL violation was near Highway 2, approximately 4 miles West of the city of New Town, ND 58763 in the county of Mountrail, in North Dakota

Please respond to the Third Party Complaint by **August 28, 2014**, with your written account of the event. Your response, the complaint, and other available information will be reviewed to determine whether Commission staff will file a formal complaint.

Your response should also address the following criteria used to determine the amount of civil penalty, if any, to be recommended by Commission staff as part of a formal complaint:

- a) The nature, circumstances, and severity of the complaint;
- b) The degree of suspected fault on the part of HALL;
- c) HALL's history of prior violations or complaints;
- d) HALL's ability to pay;
- e) Any good faith effort by HALL in attempting to achieve compliance; and
- f) The effect the penalty may have on HALL'S ability to continue in business.

North Dakota Century Code section 49-07-01.1 provides for a civil penalty not to exceed twenty five thousand dollars for violations of the One Call law.

A Cenex Pipeline aerial patrol reported excavations for two basement foundations, in which Cenex Pipeline had not receive a locate request for the work from the ND One Call. Cenex Pipeline staff investigated the site on 5/23. While on-site, the landowner, Everett Hall, came out to see why the Cenex Pipeline employee was installing additional pipeline markers and taking measurements. Per their discussion, the landowner, Mr. Hall, was the one performing the excavation work and he was aware of the one call law but said he didn't know that it applied to non-commercial excavation. Our staff advised Mr. Hall that it applies to all excavations and that he had violated the law. Mr. Hall excavated two foundations near Cenex Pipeline, one 195 feet south of the pipeline and the other 300 feet north of the pipeline. The ND One Call representative contacted MR. Hall about the incident and Mr. Hall responded that he is on private property, he has dug there before, and knows where those line are. It appears that Mr. Hall needs a stronger message.
