ONEOK Bakken Pipeline, L.L.C. – Certification Letter for Targa Lateral Pipeline Project Route Modifications (PU-14-254)

Dear Commissioners:

In accordance with North Dakota Century Code 49-22-16.3, this letter is provided to notify the North Dakota Public Service Commission (Commission) that ONEOK Bakken Pipeline, L.L.C. (ONEOK) intends to modify the route of the Targa Lateral Pipeline Project (PU-14-254) located in McKenzie County, North Dakota (Project) in two locations.

The Project is a Y-grade NGL transmission pipeline approximately 10.6 miles long. The Project will originate at the Targa Resources LLC's Little Missouri Plant and will terminate at an interconnect with ONEOK's existing Garden Creek Pipeline south of Arnegard, North Dakota. A Findings of Fact, Conclusions of Law and Order was filed on October 16, 2014 (PU-14-254). ONEOK intends to modify the Project route at milepost 8.8 and between milepost 10.1 and 10.3 to maintain a safe distance from existing infrastructure. A description of the modified route follows, and maps depicting the modifications are attached.

Milepost 8.8 route modification: ONEOK plans to adjust the centerline south of 22nd Street NW near milepost 8.8. The point of inflection will be shifted approximately 15 feet south to allow construction activities to avoid an existing fiber optic line located on the south side of 22nd Street. This modification will also allow the road to be bored without further impacts to surrounding pipelines.

Milepost 10.1 route modification: ONEOK plans to adjust the centerline between mileposts 10.1 and 10.3. The point of inflection will be shifted approximately 25 feet south to maintain a safe distance from the nearby Northern Border Pipeline.

In accordance with N.D.C.C. § 49-22-16.3(1), ONEOK certifies as follows:

1. The Project's construction activities will be conducted wholly within the existing construction corridor and all necessary right-of-way easements within the specified corridor have been acquired.
2. An environmental analysis, conducted for ONEOK in May 2014, evaluated the Project relative to the Exclusion and Avoidance Areas set forth in N.D. Admin. Code § 69-06-08-02, and the Project as rerouted will not affect any known Exclusion or Avoidance Areas .

3. ONEOK will comply with the October 16, 2014 order in Case PU-14-254 designating the corridor and designating the route and all applicable federal, state, and local laws and rules.

ONEOK requests that the Commission acknowledge receipt of the attached Certification and appreciates the time and attention provided to this matter by the Commission and its Staff. E3 Environmental, LLC has been retained by ONEOK to provide environmental consulting support for this project.
