RE: Grain Warehouse Inspection

Dear Mr. Larson:

The Public Service Commission's Grain Warehouse Inspectors recently completed a routine grain warehouse examination at Larson Grain Company (LaMoure & Adrian Locations). The inspectors:

1. Reviewed company operations to determine if generally accepted business practices and state warehousing laws and rules were being adhered to, if documents complied with statutory requirements, and if required notices were posted appropriately.
2. Physically inspected warehouse facilities, to determine if grain was being stored only in approved space and whether the stated physical capacity was accurate and adequately bonded.
3. Physically measured all grain on hand to determine if inventories agreed with company records and were of a kind, quality, and quantity sufficient to cover all outstanding storage obligations.

At the conclusion of the examination, the inspectors issued Memorandums of Adjustment (MOA). A MOA is the final product of an examination and discloses any conditions that must be corrected. The MOA was completed and presented to the Grain License Director for review and signature. Larson Grain Company (LaMoure and Adrian Locations) was asked to provide proof of corrective action to the Licensing Division.

Credit-Sale Contract means a written contract for the sale of grain pursuant to which the sale price is to be paid or may be paid more than 30 days after the delivery or release of the grain for sale and which contains: (1) the seller's name and address; (2) conditions of delivery; (3) the amount and kind of grain delivered; (4) the price per unit or basis of value; (5) the date payment is to be made; (6) the duration of the credit-sale contract; and (7) notice in a clear and prominent manner that the sale is not protected by the bond. The contract must be signed by both parties and executed in duplication with one copy retained by the warehouseman and one copy delivered to the seller.

Deficiencies; Unsigned credit sale contracts and no duration or expiration date on most of the priced later contracts.

One deferred payment contract # 96297 issued to Aberle, D. not signed. 26 priced later contracts not located and thus are not signed. Please refer to the list provided. Please contact all individuals involved with these contracts and either get them signed or purchase the grain accounted on these contracts.

Numerous priced later contracts with no duration or expiration date. The law states that credit-sale contracts must have a payment or expiration date. The future issue of priced later contracts must include an expiration date. I also suggest that all of the current priced later contract holders be notified and billed for outstanding service charges.

A report must be forwarded to the Licensing Division Office within 30 days indicating correction of deficiencies. Report to include signed copies of all the indicated credit-sale contracts, or a copy of settlement information including check number and date if the grain is purchased. A written response addressing the absence of the expiration date on priced later contracts. Please contact the Office if assistance is required or questions arise.
