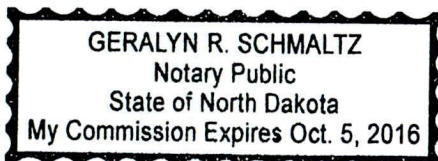

NOTICE OF OPPORTUNITY FOR HEARING

July 30, 2014

On July 17, 2014, Paradigm Midstream Services - ND, LLC, filed an application for a Certificate of Public Convenience and Necessity to construct and operate a 70-mile crude oil pipeline and other facilities to be used for the transport of crude oil from Johnson's Corner in McKenzie County, North Dakota, to Stanley Station in Mountrail County, North Dakota. Paradigm Midstream Services – ND, LLC, requests a Certificate of Public Convenience and Necessity to construct, own, and operate the pipeline as a common carrier to transport crude oil from locations located south of the Missouri River to transfer points located north of the Missouri River.


The issues to be considered in this matter are:

1. Whether public convenience and necessity will be served by the construction and operation of the crude oil pipeline and other facilities.
2. Whether the applicant is fit, willing, and able to provide service.

Those interested are invited comment on the application in writing. Persons desiring a hearing must file a written request identifying their interest in the proceeding and the reasons for requesting a hearing. Comments and requests for a hearing must be received by **September 12, 2014**. If deemed appropriate, the Commission can determine this matter without a hearing.
