

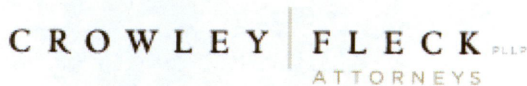



On November 15, 2016, in the above-referenced docket, Antelope Hills Wind Project, LLC ("Antelope Hills") and West Branch Wind, LLC ("West Branch") filed a joint application for the transfer of Certificate of Corridor Compatibility No. 161 and Route Permit No. 173, issued in Case No. PU-14-678, and Certificate of Site Compatibility No. 41, issued in Case No. PU-14-679, for the Antelope Hills Wind Project ("Joint Application"). As described in the Joint Application, West Branch has agreed to assume the rights and obligations of Certificate of Corridor Compatibility No. 161, Route Permit No. 173, and Certificate of Site Compatibility No. 41. The transferred rights and obligations include the rights to filing fees deposited with the North Dakota Public Service Commission and any remaining potential refund dollars associated with such filing fees that Antelope Hills made to the North Dakota Public Service Commission as part of the development of the Antelope Hills Wind Project. All filing fees and any possible refunds from the Commission associated with development of the Antelope Hills Wind Project under Certificate of Corridor Compatibility No. 161, Route Permit No. 173, and Certificate of Site Compatibility No. 41 are the ownership of West Branch.
