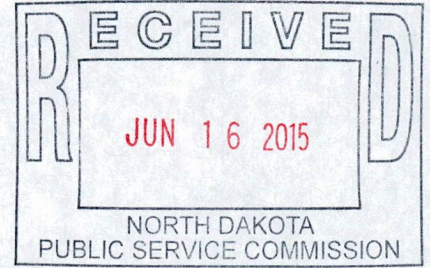

Dear Mr. Nitschke:

Following informal discussions with Mr. Jerry Lein and other North Dakota Public Service Commission ("Commission") staff, Antelope Hills Wind Project, LLC would like to provide formal notification to the Commission that, effective April 2, 2015, SUNE North Dakota Holdings, LLC has acquired all of the equity interests of Antelope Hills Wind Project, LLC from Infinity Wind Holdings, LLC. SunEdison Inc., the ultimate parent of SUNE North Dakota Holdings, LLC, is the world's largest renewable energy development company. SunEdison Inc. develops, finances, installs, owns and operates wind and solar power plants throughout the United States, delivering predictably priced electricity to its residential, commercial, government and utility customers.

Antelope Hills Wind Project, LLC remains the owner of the Antelope Hills Wind Energy Project and responsible for compliance with the terms and conditions of Certificate of Site Compatibility Number 41, issued on December 17, 2014. Antelope Hills Wind Project, LLC will continue to manage ongoing development and construction activities for the Antelope Hills Wind Energy Project. Thus, Antelope Hills Wind Project, LLC is not seeking transfer of Certificate of Site Compatibility Number 41. Rather, this notice is being provided to the Commission to ensure that the Commission is aware of the change in Antelope Hills Wind Project, LLC's upstream ownership.

Antelope Hills Wind Project, LLC has also provided formal notice of the acquisition to Mercer County and has reached out to project landowners via mail and in person about the change in ownership of Antelope Hills Wind Project, LLC. During the week of May 11, 2015, SunEdison Inc. held landowner meetings in Golden Valley, North Dakota for the Antelope Hills Wind Energy Project. During those meetings, the project team described the upstream ownership change, provided a project update, and shared a draft project schedule. SunEdison, Inc. is committed to continuing to work closely with landowners and the local communities throughout project development, construction and operation.
