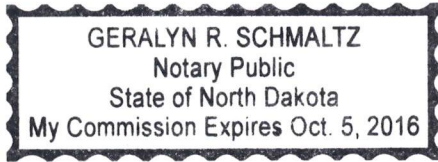

NOTICE OF OPPORTUNITY FOR HEARING

On October 6, 2014, Otter Tail Power Company, an electric public utility, filed an application under Chapter 49-03, N.D.C.C. to extend service to Inter-Community Telephone Company at a location in Barnes County, North Dakota.

Submitted with the application was a statement by Inter-Community Telephone Company that the customer desires electric service to be provided by the applicant. Service is to be provided at a point located in:
