

NOTICE OF OPPORTUNITY FOR HEARING

On September 2, 2014, Montana-Dakota Utilities Co., a Division of MDU Resources Group, Inc., an electric public utility, filed an application under Chapter 49-03, N.D.C.C. to extend service to Mark Draeb at a location in Morton County, North Dakota.
