Description (summarize the observations on which you rely to allege the violation) <i>If more space is required, please provide the description on a separate page.</i>  Contractor was excavating within the utility easement on the east side of 16th St SW and north of 37th Ave SW for the construction of a new gas station/convenience store. They had scuffed one of three 500 mcm cables on Verendrye Electric's 12.5 kv circuit five coming from our South Minot Substation. No locate was found under the contractors name. ND One Call ticket number 14140158 was created by Advanced Project Solutions for that site on Thursday August 21, 2014. The contractor proceeded to dig the next day prior to the 48 hour window for the locates to be completed.  Since the cable was scuffed only, no outage had occurred and members were affected. Repairs were made on Saturday, August 23, 2014 by VEC crews.
