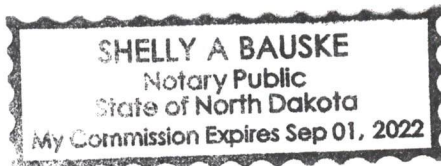

ORDER ON PROTECTION OF INFORMATION

March 13, 2019

On November 21, 2014, Blue Jay Wireless, LLC (Blue Jay) filed two applications for protective order (Applications) to protect against public disclosure of training and financial information that Blue Jay filed with the Commission, qualifying as an exemption to N.D.C.C. section 44-04-18.

The Applications state that the training and financial materials submitted with the applications qualify for trade secret protection under North Dakota Administrative Code Section 69-02-09. The Applications also contend that the training and financial materials satisfy each of the six requirements for protection set forth in North Dakota Administrative Code Section 69-02-09-01.

On December 14, 2018, Commission Staff reviewed the request recommended protection and the corresponding documents. Commission Staff recommended protection for the financial documents, however, did not believe that the application demonstrated a basis for protecting the training materials.

Having reviewed the Company's applications and Commission Staff's recommendation, the Commission has determined that the financial documentation satisfies the requirements of North Dakota Century Code for protection of information.


ORDER
