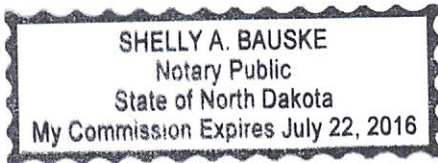

**ORDER GRANTING REQUEST
TO DISCONTINUE BUSINESS**

November 20, 2014

Southam Elevator Co. operates a public grain warehouse at Southam, North Dakota, under license number 247 issued by the Public Service Commission under the provisions of North Dakota Century Code Chapter 60-02.

On July 31, 2014, the Commission received notice that the warehouse bond issued to Southam Elevator Co. would be cancelled effective October 31, 2014. North Dakota Century Code section 60-02-09.1 provides that unless the warehouseman files a new bond at least thirty days before liability cases, the Commission, without hearing, shall immediately suspend the warehouseman's license.

As of September 30, 2014, no replacement bond was filed with the Commission. On October 8, 2014, the Commission adopted an order suspending Southam Elevator Co.'s warehouse license, effective October 1, 2014, for failing to have or maintain a bond in the amount and type required. The order provided Southam Elevator Co. had until October 30, 2014, to procure and file an adequate bond or submit a written request for hearing. No bond or request for hearing were filed.

On October 29, 2014, Southam Elevator Co. filed a request to discontinue business.


Order

The Commission orders:

1. Warehouse license number 247 issued to Southam Elevator Co. is cancelled effective October 30, 2014; and

2. Business at Southam, North Dakota, is discontinued effective October 30, 2014 and Southam Elevator Co. shall not conduct any further business under license number 247.
