Please close the Public Convenience & Necessity filing for Case No. PU-14-758.

After I began the filing process, I was made aware of the fact that the city of Verona annexed the area into the city in 2012. The land is located Section 3, Township 133N, Range 59W. Otter Tail Power Company has an electric franchise to serve the city of Verona; therefore, this filing is not required.

In my application filing, I erroneously listed the service location as Section 3, Township 133N, Range 50W. The correct Range is 59W. This error would have caused Cass County Electric Cooperative to be notified rather than Dakota Valley Electric Cooperative.
