

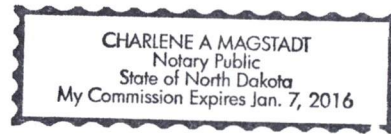


Submitted with the application was a statement by Liberty Resource LLC that the customer desires electric service to be provided by the applicant. Service is to be provided at a point located in:
