

**NOTICE OF FILINGS AND NOTICE OF HEARING**

**January 21, 2015**

On November 17, 2014, Meadowlark Midstream Company, LLC (Meadowlark) filed an application for a certificate of corridor compatibility and a route permit concerning approximately 46 miles of 10-inch diameter crude oil pipeline and associated facilities in Divide and Burke Counties, North Dakota.

Also on November 17, 2014, Meadowlark filed an application for a waiver of procedures and time schedules established under North Dakota Century Code sections 49-22-07.2, 49-22-08, 49-22-08.1, 49-22-13, and North Dakota Administrative Code section 69-06-01-02, requiring separate filings, separate notices, and separate hearings on the certificate of corridor compatibility and route permit applications.

On January 21, 2015, the Commission deemed complete the applications for a certificate of corridor compatibility and a route permit.

A public hearing on the applications is scheduled for **March 30, 2015, at 9:30 a.m. Central Time, at the Community Center, 1002 Second Street SE, Crosby, North Dakota 58730.**

The issues to be considered in the application for waiver of procedures and time schedules are:

1. Are the proposed facilities of such length, design, location, or purpose that they will produce minimal adverse effects and that adherence to applicable procedures and time schedules may be waived?
2. Is it appropriate for the Commission to waive any procedures and time schedules as requested in the application?

The issues to be considered in the applications for a certificate of corridor compatibility and a route permit are:


1. Will the location and operation of the proposed facilities produce minimal adverse effects on the environment and upon the welfare of the citizens of North Dakota?


2. Are the proposed facilities compatible with the environmental preservation and the efficient use of resources?
3. Will the proposed facility locations minimize adverse human and environmental impact while ensuring continuing system reliability and integrity and ensuring that energy needs are met and fulfilled in an orderly and timely fashion?
