Judge Mann:

It was brought to my attention this morning by John Hamre that Exhibit DA #6 (Docket No. 96) as currently filed contains only odd pages. It appears that you received a copy which failed to include the back sides of the draft North Dakota Spill Model Discussion. Mr. Bjella provided by Email dated June 25, 2015, a full copy of the exhibit to ND PSC; Attorneys Pelham, Braaten, and Van Grinsven; yourself; and Julie Prescott. Mr. Pelham informed me that he did receive a full copy at the hearing. Testimony was further offered by Chad Arey discussing DA #6, including page 12 which is not included in the docketed version, at approximately 3:45:00 of the Electronic Record of June 26, 2015 (Docket No. 84 - part 1).

It is unknown if any other parties received incomplete copies at the hearing, but it appears that most received a full and accurate copy of the exhibit. A complete copy of DA #6 is attached. We request that this copy either replace the incomplete copy at Docket No. 96, or if you should so choose that this copy be accepted as a late filed exhibit.
