SUMMARY OF PREHEARING CONFERENCE

A prehearing conference was held on June 21, 2017, in the matter of Dakota Access, LLC (PU-14-842 and OAH File No. 20160629) and an Order to Show Cause Hearing scheduled for August 16, 2017. The prehearing conference also included discussion on the Hearing on Investigation scheduled for August 17, 2017.

The prehearing conference was attended by Zachary Pelham, Pearce & Durick, Advisory Counsel for the Public Service Commission (“Commission”); John Schuh, Attorney for Advocacy Staff for the Commission; Illona Jeffcoat-Sacco, Advisor to the Commission; Lawrence Bender, Fredrikson and Byron P.A., Counsel for Dakota Access, LLC; and William Leone, Norton Rose Fulbright US LLP, Counsel for Dakota Access, LLC

The parties agreed to recommend the rescheduling of the Order to Show Cause Hearing so as to allow prehearing briefing in accordance with the following schedule:

1. Brief by Respondent is due no later than August 16, 2017.
2. The response by Advocacy Staff is due no later than September 14, 2017.
3. Any reply by the Respondent is due no later than September 22, 2017.

A prehearing conference was tentatively scheduled at 1:30 p.m. on August 3, 2017, which will be properly noticed, if needed for the Hearing on Investigation. Mr. Pelham will provide a status update regarding the need for this prehearing conference following discussions with the Respondent no later than July 28, 2017.


