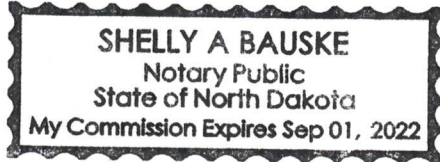

NOTICE OF CONTINUED HEARING ON INVESTIGATION

August 16, 2017

On May 31, 2017, the Commission opened an investigation under North Dakota Administrative Code section 69-02-01-08 regarding Dakota Access LLC's compliance with the Commission's orders and North Dakota siting laws and rules, excluding certain issues pending in a related proceeding. On May 31, 2017, the Commission issued a Notice of Hearing on Investigation.

On August 15, 2017, the Commission continued the Hearing on Investigation.

The continued public hearing on the investigation is scheduled to begin **October 3, 2017, at 8:30 a.m. central time in the Commission Hearing Room, State Capitol, 12th Floor, Bismarck, North Dakota 58505.**

The investigation will cover construction events reported in filings by Dakota Access, LLC and by the Commission's construction inspector, and, related to those events, the degree to which Dakota Access complied with the Commission's orders and North Dakota siting laws and rules, excluding compliance related to the October, 2016 unanticipated discovery and associated route adjustment.
