ORDER GRANTING ADMISSION PRO HAC VICE

On August 14, 2017, Lawrence Bender, of the firm of Fredrikson and Byron, P.A., filed a Motion for Admission of Andrew Elkhoury Pro Hac Vice, Norton Rose Fulbright US LLP, and also filed an Affidavit of Andrew Elkhoury in support of the Motion, with the Public Service Commission. Mr. Elkhoury seeks admission to practice Pro Hac Vice in North Dakota, representing Dakota Access, LLC, before the Public Service Commission in PU-14-842. On November 14, 2016, Administrative Law Judge Timothy J. Dawson was designated to preside as procedural hearing officer in PU-14-842, and was requested to rule on Mr. Bender's motion.


