NOTICE OF RECEIPT OF REVISION APPLICATION

March 25, 2015

Coyote Creek Mining Company, L.L.C. has filed an application for Revision No. 1 to Surface Coal Mining Permit NACC-1302 to add 352.1 acres to the permit area for a haul road, coal handing and stockpile facility, and two additional sedimentation ponds. The revision updates the introductory, legal, financial, compliance, environmental, operations, and reclamation plans to reflect the additional area and facilities. The land being added to the permit is located in:

Portions of Sections 7, 8, 9, 10, and 18, T143N, R88W, all in Mercer County.

You may submit written comments or objections on the proposed revision application and its effects on the environment and on surface owners of the land within and adjacent to the proposed permit area. You may also request an informal conference with the Commission and the applicant on the revision application. The reasons for requesting an informal conference must be stated in the request. Written comments, objections, petitions to designate lands unsuitable for mining, or requests for an informal conference must be filed with the Commission by May 11, 2015.


If there is an informal conference, you may request a formal administrative hearing on the Commission ruling on the application. Your request for a formal hearing must be made within thirty days of the Commission ruling on the application.
