CLAIM OF RONALD E. ADAMS

PSC Case No. GE-15-36

¶1 Ronald E. Adams asserts a claim in the above entitled proceeding based on a quantity of 6,232.33 cwt of beans delivered to Grand Forks Bean Company, Inc. in October of 2010. The Scale Ticket Summary prepared by Grand Forks Bean Company, Inc. are attached to this Claim as Exhibit A. A copy of some of the scale tickets are attached as Exhibit B. The claim is in the amount of \$292,919.51, together with interest accruing at the rate of 6% per annum from and after March 29, 2012, which after the date on which claimant Ronald E. Adams requested said beans be sold. Said claim is based on a quantity of 6,232.33 cwt of beans priced at \$47.00 per cwt.


¶2 Ronald E. Adams asserts a claim in the above entitled proceeding based on a quantity of 1,545.91 cwt of beans delivered to Grand Forks Bean Company, Inc. in September of 2012. The Scale Ticket Summary prepared by Grand Forks Bean Company, Inc. is attached to this Claim as Exhibit C. A copy of the scale tickets are attached as Exhibit D. The claim is in the amount of \$64,928.22, together with

interest accruing at the rate of 6% per annum from and after December 31, 2012 the date on which claimant Ronald E. Adams requested said beans be sold.

¶3 Ronald E. Adams total claim is for 7,778.24 cwt in the total amount of \$357,847.73, plus interest accruing at the rate of 6% per annum on \$292,919.51 from and after April 1, 2012, and on \$64,928.22 from and after January 1, 2013.

¶4 Although a signature of the name "Ron Adams" appears on the Grower signature line, and initials "R A" appear in the disclaimer box, Mr. Adams did not sign nor authorize his signature or initials on the Agreement. Until the Price Later Agreement was obtained from the PSC, it had never been seen by Mr. Adams.
