Susan K. Richter, being first duly sworn, deposes and states as follows:


1. I am a citizen of the United States of America, of legal age, residing at Bismarck, North Dakota.

2. I previously submitted an affidavit in this case on February 13, 2015, which is incorporated herein. Doc ID# 4. As described more fully in that affidavit, Grand Forks Bean's inventory was sold and the proceeds deposited at the Bank of North Dakota. As of September 1, 2015, the balance of the account holding the proceeds of the sale is \$767,861.78. A true and correct copy of the most recent bank statement at the time of filing this affidavit is attached hereto as Exhibit 1.

3. Grand Forks Bean operated its warehouse at Grand Forks, North Dakota under license number 1164. A true and correct copy of the License is attached hereto as Exhibit 2. Grand Forks Bean has filed a bond with the Commission as required by N.D.C.C. § 60-02-09 in the amount of \$100,000 and identified as number 077708 66024305. A true and correct copy of the bond is attached hereto as Exhibit 3.


4. The Public Service Commission has incurred expenses and fees relating to this case, including costs for potage, publication of notices, legal and miscellaneous expenses. As of September 1, 2015, the associated costs relating to this case are \$6,912.30. A true and correct copy of the documentation associated with these expenses as of September 1, 2015 is attached hereto as Exhibit 4. Given the nature of this proceeding, additional expenses have been and will continue to be incurred, and the amount of expenses claimed is intended to be updated.
