
**AMENDED
CLAIM OF CHUCK NELSON**

PSC Case No. GE-15-36

¶1 Chuck Nelson asserts an amended claim in the above entitled proceeding in the amount of \$49,973.04, together with interest from and after October 15, 2013. Said claim is based on a quantity of 1,315.08 cwt of beans priced at \$38.00 per cwt, being the market price of said beans prevailing on the date of the insolvency. Chuck Nelson asserts the date of insolvency of Defendant Grand Forks Bean Company, Inc. was no later than October 15, 2013..

¶2 The Price Later Marketing Agreement #1106 and Scale Ticket Summary prepared by Grand Forks Bean Company, Inc. are attached to this Claim as Exhibit A and the Dry Bean Contract is attached as Exhibit B. Although a signature of the name "Chuck Nelson" appears on the Grower signature line, Mr. Nelson did not sign nor authorize his signature or on the Agreement. Until the Price Later Marketing Agreement was obtained from the PSC, it had never been seen by Mr. Nelson.
