Dear Mr. Morley:

Thank you for your letter dated July 6, 2016 requesting clarification of paragraph 2, on page 8, of the July 5, 2016 order. Paragraph 2 currently references the PSC's "claimed fees and expenses." The reference to "claimed fees and expenses" includes recognition that the PSC has requested a 50/50 allocation of its fees and expenses between the trust fund in the present action and the Credit-Sale Contract Indemnity Fund established pursuant to Chapter 60-10 of the North Dakota Century Code; the PSC's recovery of fees and expenses is limited by the 50/50 allocation. Unless another party believes that the order requires a different interpretation an amended/corrected/clarified order will not be entered.
