[¶1] On September 2, 2016, a notice of appeal was filed by Bremer Bank in this matter. Prior to the filing of the notice of appeal, a motion for post-judgment relief under N.D.R.Civ.P. 52(b), 59(j) and 60(b), was filed by Auto-Owners Insurance Company. A request for a limited remand so the district court can take action on the pending motion was received September 7, 2016, from Auto-Owners Insurance Company.
