Description (summarize the observations on which you rely to allege the violation) <i>If more space is required, please provide the description on a separate page.</i> Enbridge aerial patrol called Chris Schaefer and told him that there was equipment close to Enbridge lines between 86th ave and 87th ave west of Stanley. An employee went out to check it out and found J&J Oilfield service was digging up rocks in the field in the SE quarter of the section. 156N 92W section 27. In a couple of spots they were within 50ft of and Enbridge line and they had been driving equipment and loaded semis over the lines. They were out doing this work without a one call. We met with JJ the owner of J&J and told him what he was doing was illegal and that he had broken the state one-call law. After that Enbridge employees flagged the half mile of our pipelines. J&J stopped digging and were asked to not cross our lines anymore with his equipment or be within 100ft of our flags. He did stop digging and moved his equipment away from our lines.
