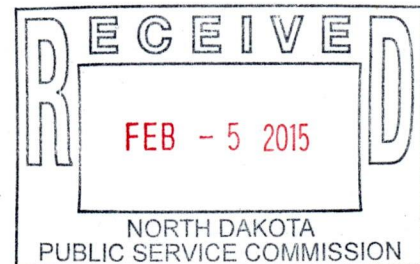

RE: OIL PIPELINE TARIFF FILING

Dear Mr. Nitschke:

Tesoro High Plains Pipeline Company LLC (THPP) files the accompanying tariff, North Dakota P.S.C. No. 96, with an issue date of February 4, 2015, to be effective on February 7, 2015.

North Dakota P.S.C. No. 96 cancels North Dakota P.S.C. No. 95.

THPP is filing North Dakota P.S.C. No. 96 to add a new route from Ramberg Station, Williams County, to the Bakken Area Storage Hub and other Intrastate Destinations at Ramberg. The rate for this transportation will be five cents per barrel.

Pursuant to Section 49-05-05 of the North Dakota Century Code, THPP hereby requests that the Commission permit the changes indicated in this tariff to become effective on less than 30 days' notice.



APPLICATION OF RATES FROM INTERMEDIATE POINTS

Rates from any origin not specified above to Mandan, North Dakota shall be the rate indicated for the North Dakota Station listed above that is the closest geographic point on the pipeline to the unspecified origin.

Pumpover Fee: When shipments are transferred from tank or truck facilities into the main line facilities of Tesoro High Plains Pipeline Company, LLC, a charge of [U] 18.22 cents per barrel will be made in addition to the transportation rate stated above.

*The Gathering Rate for the Movement from Chimney Butte to Connolly Station is [U] \$1.002 per Barrel. The Gathering Rate for movement on the Corral Creek Gathering System (points of origin upstream of Chimney Butte, for delivery into the Gathering System at Chimney Butte) for up to 1,000 Barrels per day ("bpd") is [U] \$0.332 per Barrel and the volume incentive rate for volumes greater than 1,000 bpd is [U] \$0.301 per Barrel.
