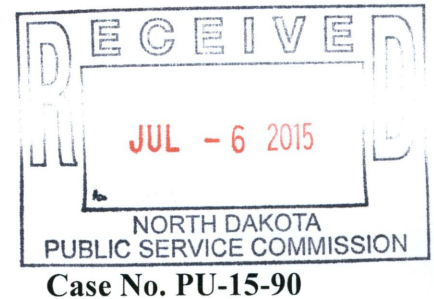

ORDER GRANTING ADMISSION PRO HOC VICE

July 2, 2015

On May 26, 2015, David A. Tschider, of the firm of Tschider & Smith, filed a Motion for Admission Pro Hoc Vice, and Affidavit of John B. Coffman, with the North Dakota Public Service Commission. Mr. Coffman seeks admission to practice pro hac vice in North Dakota, representing AARP, before the Commission in PSC Case No. PU-15-90. On February 26, 2015, Administrative Law Judge Wade C. Mann was designated to preside as procedural hearing officer in Case No. PU-15-90, and was requested to rule on Mr. Coffman's motion.

The administrative law judge has reviewed the motion and affidavit and finds that Mr. Coffman has met the requirements of the North Dakota Supreme Court Admission to Practice Rule 3 for admission pro hac vice to practice in North Dakota before the Commission in Case No. PU-15-90. Accordingly, the motion is granted and it is **ordered** that John B. Coffman may practice in North Dakota before the North Dakota Public Service Commission representing AARP, in Case No. PU-15-90.
